Note regarding the processing of your personal data:

The Fritz Thyssen Stiftung takes the protection of your personal data very seriously. We would therefore like to notify you whether and which of your data we collect, process and use. Our obligation pursuant hereto emanates above all from the General Data Protection Regulation (GDPR).

Personal data is deemed to mean all information that relates to an identified or identifiable natural person. Personal data therefore includes for example your name, the address where you reside, your gender, your date of birth, your age, your telephone number, your e-mail address or your IP address. This list is not exhaustive and is merely intended to indicate to you what may fall under the rubric of personal data.

Within the framework of the application, we only request that data, and in particular that personal data, from you which is necessary for the processing of, and deciding on, your application and possibly its approval under Art. 5, Art. 6, section 1, subsection 1, letter b) of the General Data Protection Regulation. We store your personal data on a permanent basis - regardless of whether the application is approved or not.

Applications for project support are assessed by experts in accordance with the usual standards of scholarship, research and science. It is only in this manner that the Foundation can review and ensure that the research project is indeed eligible for support in the meaning of Art. 3 of the Foundation's Statutes.

That is why it is necessary under Art. 5, Art. 6, section 1, subsection 1, letter b), Art. 49, section 1, subsection 1 b) of the General Data Protection Regulation that we provide your application including personal data emanating from your application to the members of the Foundation's institutions and/or to external appraisers that may reside in Germany, the EU/EEZ and in countries outside the EU (third countries). These persons are subject to applicable data protection regulations.

The Foundation wishes to rule out both parallel applications for funding being filed as well as double funding in principle. To this end, the Fritz Thyssen Foundation reserves the right in accordance with Art. 6 section 1 subsection 1 letter f) of the GDPR to submit enquiries to other funding providers (other funding institutions) in which it discloses the name of the applicant and the title of the project. The Foundation also provides the said data to other funding providers in accordance with Art. 6 section 1 subsection 1 letter f) of the GDPR in order to determine whether there is possible double funding or parallel application for funding.

A large number of project applications are submitted to the Fritz Thyssen Foundation every year. To ensure that these project applications can be processed efficiently with the limited human-resource capacities of the Fritz Thyssen Foundation's administrative office, the Foundation sends the project applications to a small group of external persons for the sole purpose of having a summary of their content drawn up in accordance with Art. 6 section 1 subsection 1 letter f) of the GDPR. These external persons are obligated by the Foundation to treat your application and the personal data contained therein confidentially and are subject to applicable data protection provisions. These summaries will in no case affect the Fritz Thyssen Foundation's decision on your application.

Please note that we shall not process your application or have it assessed if you do not provide us with your personal data. The Foundation moreover reserves the right to report on projects approved for support both in its annual report as well as on its website. These forms of publication are not associated with any assessments.
